

**FINDINGS AND RECOMMENDATION OF THE
LOCAL DEVELOPMENT ACT REVIEW COMMITTEE FOR THE
CRUTCHFIELD NEIGHBORHOOD ECONOMIC DEVELOPMENT PROJECT PLAN**

After review of the proposed Crutchfield Neighborhood Economic Development Project Plan ("Project Plan"), its proposed creation of six tax increment districts, and other relevant information, the Local Development Act Review Committee ("Review Committee") makes the following findings and recommendation:

A. Findings Regarding Eligibility of the Proposed Project Area and Increment Districts

1. The proposed Project Area and the proposed Increment Districts A through F ("Increment Districts") are within a state designated enterprise zone and therefore meet the definition of an "enterprise area" under the Oklahoma Local Development Act ("Act") (62 O.S. § 853(5)).
2. The proposed Project Area and the proposed Increment Districts meet the definition of a "reinvestment area" under the Act (62 O.S. § 853(17)).
3. The level of investment, development, and economic growth desired by the City of Tulsa is difficult, but possible, within the proposed Project Area and Increment Districts if the provisions of the Act are utilized.
4. Tax increment financing is a necessary component in stimulating reinvestment in the proposed Project Area and Increment Districts.
5. Tax increment financing will be used to supplement and not supplant or replace normal public functions and services in the proposed Project Area and Increment Districts.
6. Tax increment financing will be used in conjunction with existing programs and efforts and other locally implemented economic development efforts.
7. The Project Plan emphasizes conservation, preservation, and rehabilitation.

B. Findings Regarding Financial Impact on the Affected Taxing Jurisdiction and Business Activities Within the Proposed Project Area and Increment Districts

1. As described in Sections IX through XI of the Project Plan, the anticipated private development will generate tax increments sufficient to pay a substantial portion of the authorized project costs of the project proposed by the Project Plan. Without the Project Plan and Increment Districts, the development described in the Project Plan and the resulting increases in tax revenues would not occur.
2. The development anticipated by the project may result in slight increases in demand for services by or in costs to the affected taxing jurisdictions.
3. The public revenue anticipated to result from the development described in the Project Plan includes increased tax revenue beyond the revenues being apportioned

to pay Project Costs, as defined in the Project Plan, and included economic growth and benefits outside of the Increment District.

4. The economic benefits of the Project Plan for the affected taxing jurisdictions and the community as a whole offset any adverse financial impacts of the Project Plan on the affected taxing jurisdictions.
5. The aggregate impacts of the affected taxing jurisdictions and on business activities from implementation of the Project Plan are positive and include the achievement of the objectives set forth in Section IV of the Project Plan.

C. Recommendation

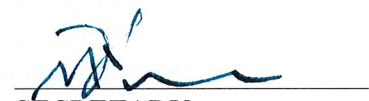
1. Based on the findings made in paragraphs A and B of this document and approved by the Review Committee, the Review Committee hereby recommends that the City Council of the City of Tulsa approve and adopt the Project Plan, including creating the proposed Increment Districts.
